### **NOTIFICATION**

In exercise of the powers conferred by section 585 read with section 592 of the GHMC Act, 1955; proviso under sub-section (1) read with sub-section (2) of sections 14, 32, 46 and 58 of the Telangana Urban Areas (Development) Act, 1975, section 56(1) of the Hyderabad Metropolitan Development Authority Act, 2008, section 18 of the Telangana Municipal Corporations Act, 1994; section 326 of the Telangana Municipalities Act 1965, the Government of Telangana hereby makes the following amendment to the Building Rules 2012 which were issued in G.O.Ms.No.168, MA&UD (M) Dept., dt.07.04.2012 and as amended from time to time.

2 This amendment is applicable to all pending Building applications also.

#### **AMENDMENT**

In the Rule 15, after sub-rule (b) following shall be added as sub-rule(c) namely -

(c) "In case of Commercial / Industrial / Residential building constructions over 10,000 Sq. Mts area and above, provision shall be made in the plans for Sewage Treatment Plant (STP) which shall bring sewage and domestic discharge within the prescribed parameters. Further such plan should duly provide for a complete and comprehensive system of collection, transportation and disposal of municipal solid waste strictly in accordance with the Solid Waste Management Rule - 2016".
