ORDER\$:

In the reference 2nd read above, the Director of Town and Country Planning has informed that, the Department of Expenditure (Public Finance – State Division), Government of India, New Delhi has issued certain guidelines to Spur Economic Growth in the country through reforms in Building Regulations for Industrial and Commercial Buildings. The Director of Town and Country Planning has emphasized the need to amend the Building Rules in respect of Commercial Buildings and liberalizing the Building Regulations to encourage growth of commercial building and submitted the proposals to the Government for amendment of Building Rules in respect of commercial Buildings.

2. Government after careful examination of the matter, hereby issue the following amendments, to Telangana Building Rules issued in G.O.Ms.No.168, MA, dated.07.04.2012 read with its subsequent amendments, under Reform-3: Encourage of growth of commercial buildings.
